### 9. STAFF AND FIRE CHIEFS REPORT:

9.1 OPERATIONS – Chief Ramirez provided a report on the calls and automatic aid for the month of May.

- 9.2 FIRE PREVENTION/PUBLIC EDUCATION —Chief Ramirez noted that he continues to monitor the cannabis business that is subleasing a location in the District. At this time, they have not been approved to build because there is a pump that needs to be in compliance that is not running at 1,000 gallons per minute. The County passed an ordinance that cannabis operations will be taxed 3% for public safety. Chief Ramirez talked to the Board of Supervisors about this tax because it should go to the Fire Districts; however, right now these funds are not allocated to Fire Districts. Chief Ramirez asked the San Joaquin County Chief's Association to approach the Board of Supervisors in regards to allocating a portion of the taxes to Fire Districts in the County.
- 9.3 TRAINING Chief Ramirez noted that the wildland training class has been completed for the Reserves- six will be able to go to Strike Teams. The plan will be to send three paid staff and one Reserve; however, if staffing is not available the District will send two paid staff and one Reserve. This will allow the Reserves to get further training and experience on the Strike Teams.
