- B. FY 2020 Assistance to Firefighters Grants (AFG) Application Water Tender By consensus of the Board Chief Ramirez is directed to apply for a FEMA FY 2020 AFG Grant for the water tender. The water tender is approximately \$340,000. If the grant is awarded, the District cost share between 5%-10%. This grant is awarded is October 2021.
- C. 2022 California Office of Traffic Safety Grant Application Liberty Fire Chief Ramirez partnered with Liberty Fire to host a regional grant application for additional extrication equipment. Chief Ramirez and Captain Weber wrote the grant. The regional grant includes Liberty, Woodbridge, Lodi, and Mokelumne Fire. If awarded, this is a zero cost share grant.
- 7.3 LEASE OF NEW ENGINE Chief Ramirez noted that the lease of the new engine has been approved. The engine is in Rancho Cardova and they are working on paint. The seats ordered were the wrong ones; however, they are being modified. The engine should be delivered next month.
