#### 7. OLD BUSINESS:

## 7.1 STATION IMPROVEMENTS

- A. STATION ADDITION PROJECT Chief Ramirez plans to discuss the plans with San Joaquin County staff to ensure that the project will be approved with the new square footage. There may be a need to request a variance for the land use.
- B. SOLAR PROJECT Chief Ramirez noted this project is on hold due to the current projects.
- C. WASHROOM PROJECT Chief Ramirez noted that staff has removed the asphalt and plans to have the pad poured by the end of the month.

Director Tamura arrived at this point of the meeting.

- D. SIGN PORJECT Chief Ramirez noted that this project is complete and is working with the County to finalize the permit process.
- E. Fill Station for SCBAs (Compressor) Chief Ramirez noted that the compressor has been installed and is up and running.
- F. Generator Chief Ramirez noted the generator should arrive by the end of next month. The space is ready for the new generator and was paid through a grant.
- G. Outside Cover Captain Weber noted that he priced out two separate covers. One will be a drive through; however, the one for the antique will have a back cover the amount of the purchase \$26,500. The Board directed staff to lock in a price because the price of materials may increase.
- H. APP Bay Lighting Replacement Chief Ramirez noted that the lights have been ordered and once they are received the install will be completed.

#### 7.2 GRANT UPDATES

- A. FY 2020-FY 2021 San Joaquin Community Power Resiliency Project Grant Award Chief Ramirez has received the reimbursement for this grant. The only thing waiting on this grant is the installation of the generator.
- B. CSFA Volunteer Grant Chief Ramirez noted that the structure gear and physicals for volunteer staff have been ordered for nine personnel. This is a 50-50 cost share grant. The reimbursement for this grant has not been received.
- 7.3 NEW ENGINE Chief Ramirez noted that there were a couple of warranty issues with the new engine that have been resolved.
- 7.4 COVID-19 VACCINATION PARTICIPATION Staff have assisted with administering vaccinations at the Lockeford Community Center. Chief Ramirez has asked if there could be a monthly vaccination event in the

Lockeford Community. Staff have also been helping in neighboring Districts.
