7. OLD BUSINESS:

7.1 STATION IMPROVEMENTS

- A. STATION ADDITION PROJECT Chief met with Roland Construction. Roland Construction will create a material list to help Mokelumne staff buy the materials and do most of the work themselves. There was some discussion on an addition that reduces noise and reduces heat at a cost of \$12,000. Roland Construction suggested not adding this item and adding it later. The Board directed Chief Ramirez to eliminate this item from the project because it reduces cost and adds visibility of the front parking area for the employees. Also, they suggested adding a 10-foot drop ceiling versus an 8-foot ceiling. Chief Ramirez is still looking at the final numbers of materials and cost which will be brought to the Board at a future meeting.
- B. SOLAR PROJECT Chief Ramirez noted this project is on hold due to the current projects. The Station Addition Project is the priority right now to get the extra room for staff sleeping arrangements.
- C. WASHROOM PROJECT Chief Ramirez noted that this project will move forward once the sign project is completed. The washer will be ordered.
- D. SIGN PORJECT Chief Ramirez noted that this project is almost completed and may be up and running soon. There will be some landscaping improvements done around the sign and along the fence near the Digital Sign.
- E. Fill Station for SCBAs (Compressor) Chief Ramirez noted that the compressor will be shipped on 3/18 and it will be prepared for installation; hopefully, this will be installed at the end of March or the beginning of April 2021. Bauer will remove the old compressor.
- F. Generator Chief Ramirez noted the generator has been ordered and at this time there is no information on when it will be delivered.

7.2 GRANT UPDATES

- A. FY 2020-FY 2021 San Joaquin Community Power Resiliency Project Grant Award Chief Ramirez has submitted for reimbursement for this grant.
- B. FY 2020 Assistance to Firefighters Grants (AFG) Application Water Tender Chief Ramirez updated the Board and let them know that this grant was submitted. Captain Weber and Administrative Assistant Lorena Coose wrote this grant. Chief Ramirez reviewed the grant and submitted it. This grant is awarded in October 2021.
- C. 2022 California Office of Traffic Safety Grant Application Liberty Fire submitted the regional grant for extrication equipment.

- D. FEMA SAFER Grant Chief Ramirez noted that this grant is for hiring personnel. This is a three-year grant that covers 100% of personnel costs for additional staff. There is zero cost share. By consensus of the Board, the Board directed Chief Ramirez to apply for the grant.
- E. CSFA Volunteer Grant Chief Ramirez noted that this grant is for structure gear and physicals for volunteer staff. By consensus of the Board, the Board directed Chief Ramirez to apply for the grant. This is a 50-50 cost share grant.
