6.2 FINANCIAL REPORTS - UNPAID BILLS REPORT

Motion to approve the June 2021 Financial Report. Director Sperling noted that the financial reports were reviewed for June 2021. Director Sperling noted that the expenses for this month were at \$128,345.22. Chief Ramirez noted that Dennis Holland was paid approximately \$30,000 for a Strike Team sponsored under the Fire District. The District was paid approximately \$4,000 in administrative fees. There was also a payment of \$39,087.37 to Santander Bank for the first payment of the Type III Engine.

7.1 STATION IMPROVEMENTS

- A. STATION ADDITION PROJECT Chief Ramirez noted that this project is still on hold.
- B. SOLAR PROJECT Chief Ramirez noted that this project is still on hold.
- C. WASHROOM PROJECT Chief Ramirez noted that staff has poured the slab. The framing will start soon.
- D. Generator Chief Ramirez noted the old generator will be purchased by Delo Electric for approximately \$6,000. The amount will be deducted from the work to be performed to install the new generator. Before the generator is installed there is some work to see if the meter is the right size to run the generator. Delo Electric is working with PG& E to confirm.
- E. Outside Cover Chief Ramirez noted that the final price including freight for the two outside covers is \$26,448.32. Staff will install the covers, so there is no install fee. By consensus of the Board, the Board directed Chief Ramirez to move forward with the purchase of the two outside covers.
- F. APP Bay Lighting Replacement Chief Ramirez noted that this project has also been put on hold until the lift can be scheduled.

7.2 COVID VACCINATIONS

Chief Ramirez noted that he is staying up to date with Covid-19 vaccination guidelines. New hires will be required to have the Covid-19 vaccine. All staff is required to wear masks when they are out in the public. At this time, unvaccinated personnel are required to wear a mask indoors. The plan is to mandate vaccinations for current staff once the vaccine is approved by the FDA. Chief Ramirez noted that the San Francisco Fire Department has issued a statement noting that all employees are required to take the vaccine or they will be terminated. Chief Ramirez will monitor OSHA Guidelines and make adjustments as necessary.
